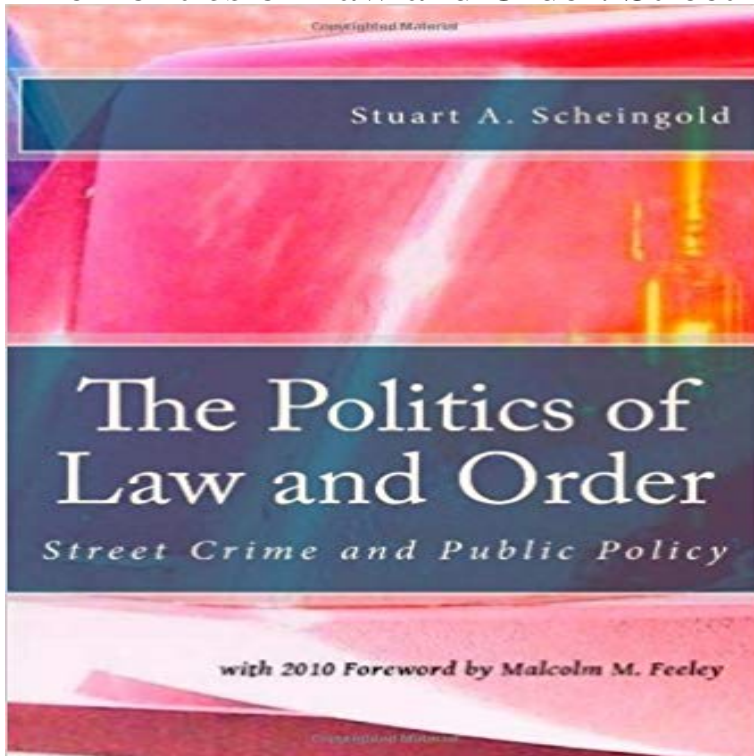


The Politics of Law and Order: Street Crime and Public Policy
