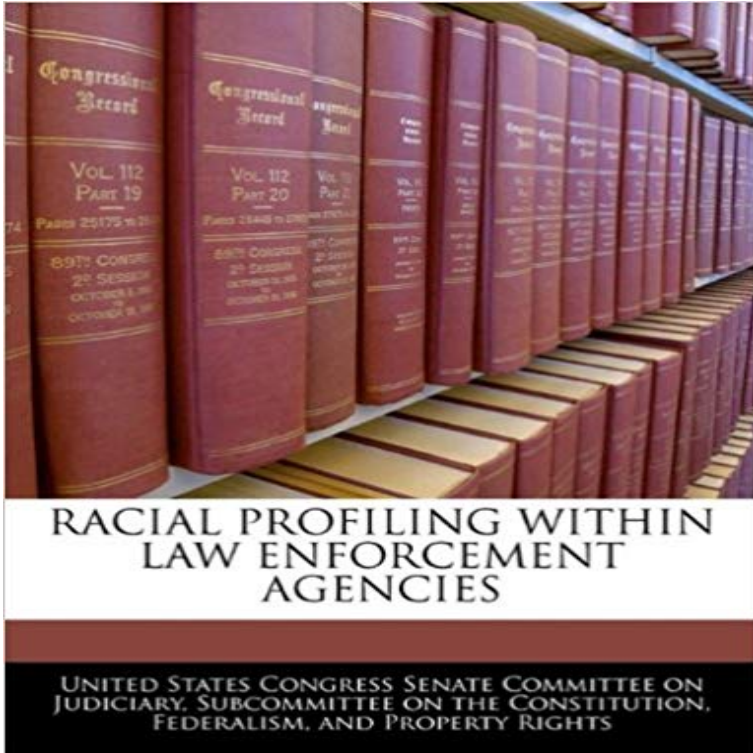


RACIAL PROFILING WITHIN LAW ENFORCEMENT AGENCIES
