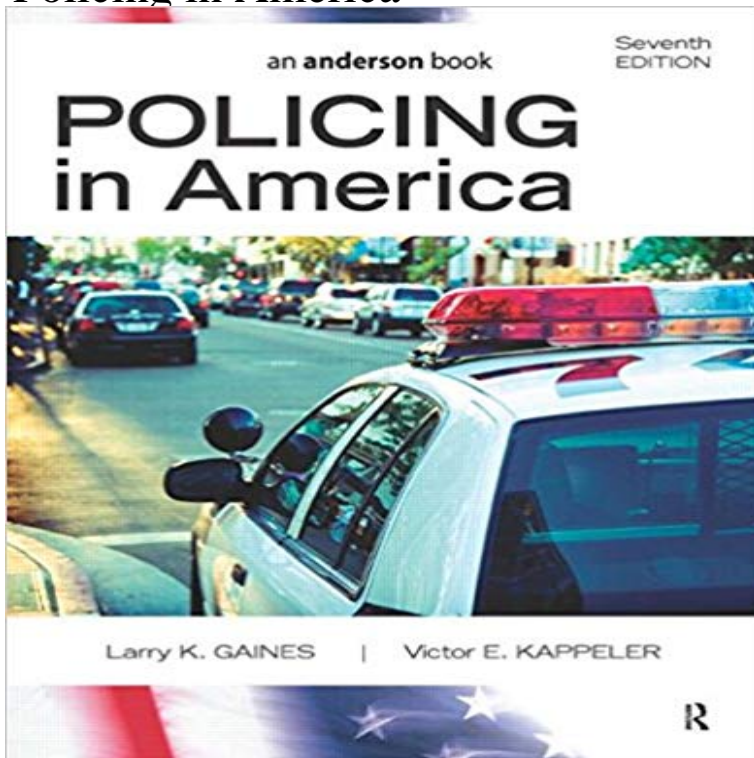


## Policing in America
